1. Online applications are invited till 21.09.2015 for filling up of 3 (three) posts of Driver in Orissa High Court in the Scale of Pay of Rs.5200-20200/- & Grade Pay of Rs.1900/- along with other allowances as admissible to State Government employees from time to time. 2. **Age Limit:** The candidate shall not be below 21 years of age and above 35 years of age as on 01.01.2015.

Upper age limit is relaxable up to 5 years in case of SC, ST & SEBC Candidates.

3. **Qualifications:** The candidates should have passed H.S.C. Examination and possessed of valid L.M.V. Driving License with knowledge of Motor Vehicle Mechanism. The candidates must have 3 (three) years experience in driving of Light Motor Vehicle (L.M.V.) in any Government or recognised organisation.

The Candidates must be willing to work even at odd hours and on Sundays / Holidays.

4. **Examination Fee :** The candidates are required to pay a non-refundable and non-adjustable fee of Rs.100/- (Rupees one hundred) only in shape of Treasury Challan under the Head "0070-other Administrative Services – 01 – Administration of Justice – 501 – Services and Service fees – 9903220 - Home Department – 9915770 – Examination Fees" or through **ONLINE** by using Credit Card/ Debit Card/ Net Banking System. **The SC and ST candidates are exempted from paying the Examination Fee.**

(B)	<b>Practical Test:</b>		
	<b>i. Driving Skill :</b> To adjudge the driving skills of the candidate, Road Sense, Road Safety, Manners, Attitude and Behaviour.	25	15
	<b>ii. Mechanical Skill :</b> To adjudge whether the candidate possesses good knowledge of Petrol, Diesel and CNG Engines working, vehicle mechanism, technical aspect and whether he is able to locate fault, rectify and carry-out minor running defects to assess the ability to change wheels, correctly inflate tyres, clear carburettor and plug etc.	25	15
